#### Details of the pre-application advice received

The following note was sent by Neil McDonald, he is the team manager of Blythe Smith and on 1st of March 2024, the following information was received:

I should say that whilst the existing side extension is not an attractive feature this is more to do with its poor state of condition rather than its scale, form or design and is in itself of some historic interest with the ironwork of its supporting structure. However that is not to say that we don't think there is scope for a suitably sympathetic replacement extension. The officer pre-application advice does give guidance as to what we would consider acceptable in this regard. To clarify this, if not already clear this is what you would need to do

1. The upper ground floor height and plan-form in the second pre-app option (adhering to the confines of the existing side extension at this level) is appropriate; however its side elevation window should be omitted (it should maintain the appearance of a flank wall to the property since this is what it is); and the front elevation window should be redesigned to match the corresponding side extension to the adjoining house of the pair (34 Upper Park Road).

2. The lower ground level element of the extension should be set back in line with your original pre-app option. The splayed footprint starting in line with the upper ground element to the front and splaying outwards parallel to the courtyard wall on Tasker Road would be acceptable. The extension needs to retain the sense of a gap between it and the wall to avoid appearing as 'overdevelopment', so your second pre-app option extending to the wall would not be acceptable. Also, the 'lean-to' mono-pitched roof design in this option would be clearly visible above the wall in views from the street and would appear clumsy at its juncture with the retained area of courtyard at the Tasker Road entrance and with the building known as Tasker Lodge.

3. The lower ground floor element should also present a more traditional street facing appearance in keeping with the style of these Upper Park Road villas and their side extensions with a central window opening aligning with the one above. The materiality should match that of the lower portion of the host building in stucco render and we would further encourage you to introduce similar external detailing (raised horizontal banding between floor levels, moulded cornice below parapet, flat architrave around the front window etc.) to align with the existing side extension to No. 34.

Therefore, my advice would be to revert to us with a new planning application paying heed to the above 3 points.
