Tree crs.1 - Prunus avium. WORKS: Fell to ground level and treat stump with herbicide. Replant in centre of garden with x1 Gleditsia tricanthos inermis.

REASON: Tree has placed direct pressure against adjacent brick boundary wall, which is also a 4m high retaining wall with church to the north. Cracks have appeared in the neighbours side of the wall, with rotational movement being visible in the garden of 5 Crestfield (see attached photos). The retaining wall is a section of wall that starts at approx 2m into garden of 5 Crestfield and ends at approx 2m from rear of 57-58 Birkenhead St building. Rotation of the entire section of retaining wall is visible. Tree recently caused boundary wall with 57-58 Birkenhead Street to collapse, although wall has just been rebuilt with a lintel span.
