List 775 (05/02/24)

2024/0325/T. 38, Dartmouth Park Road The felling of this Cedar (T1)has been approved. (However the results described are that of 2024/0322/T at 23, Belsize Crescent NW3).

2024/0333/T. 106, Chetwynd Road No objection to work on T1(Lime) as reduction to previous points. No objection to the work on T2 (Bay) as general maintenance.

2024/0345/T 3 Brookfield Park No objection to the work on this newly approved TPO'd Copper Beech tree (T1).

2024/0420/T. 6, Glenhurst Avenue No objection to the crown reduction of the Magnolia (T1).

List 776 (12/2/24)

2024/0502/T. 57 Woodsome Road

No objection to the reduction of the Bay (T1) and the removal of the overhang. No objection to the work on the Fig (T2) as it is to the previous pruning points. No objection to the routine maintenance work on the Ceanothus (T5).

2024/0516/T. 48, Laurier Road, NW5

l personally do not object to any of these tree works, many are reduce to previous points, general maintenance and are much needed. The (T3) is rotten at the base and is a possible hazard. The Group of Limes (G7) need

maintenance and their presence will compensate for the removal of the Lime (T6) which is adjacent to, with insufficient clearance to the house.

2024/0545/ T. 12, Doynton Street No objection to the reduction in height of lateral spread of this large Plane tree.

The application form states that the Oak (T) has a TPO served upon it, but number not stated. No objection to the current pruning application, but should be carried out at regular intervals.

(I did notice small cracks around the adjacent manhole cover. Maybe it should be lifted and the drains inspected for the presence of tree roots).

La Sainte Union Convent School front and rear grounds No objection to the work on the Cedar of Lebanon, (with a TPO), as it has insufficient clearance to the building as it is touching it. Also No objection to the work on the Ash (T92) as it is also touching the building. No objection to the reduction work on the bifurcated Ash (T21).

2024/0755/T 22-24, Swains Lane, Clarion Housing Offices No objection to the work to remove the regrowth on this Ash (T1), with a TPO in the front garden. No objection to the removal of the ivy at 1.5m on the trunk.
