Mature Quercus Ilex, height of c. 15 metres, crown spread 15 metres, girth c. 2 metres Position: 2.5 metres from rear elevation of house, and overhanging roof of house
Proposed work: crown reduction of 30%, concentrating on side overhanging house; and crown thinning by 20% to reduce stress on extended limbs

Reason: the tree has a Ganodermal fungal infection and will need progressively to be reduced over the next 20 years
