T1: Mature Beech: Approximately 14.00m: Remove epicormic growth from main stem. Reduce back to previous points, approximately1.20m-1.50m whilst preserving the main branch scaffold. Thin crown density by 20%. Remove major dead wood throughout crown. General maintenance.
