Description of Proposed Works
Please describe the proposed works
The works to 3 Camden Square involve the modification and extension of the existing glazed side extension at Ground Floor in order to create an annex. The existing pitched glazing will be removed, and the wall squared off to create a flat roof with a series of roof lights. The existing, uninsulated fabric of the boundary wall and concrete slab above will be insulated, improving thermal performance of the building. The front of the extension is stepped out to behind the quoining of the main house in order to also accommodate the main entryway with utility and cloakroom facilities. At the rear, a portion of the existing glazed screen will be replaced with a solid wall, with the remaining glazing being refurbished as far as possible for use in the proposed opening.
