## **Householder Application Granted**

Address: 11 Mansfield Place London NW3 1HS

Proposal:

Replacement of single-glazed, timber frame sash windows on front elevation with doubleglazed like-for-like units.

Drawing Nos: Site location plan, Exis\_Pro\_Front\_Elev (rev A), Exis\_Win\_Type\_1 (rev A), Pro\_Win\_Type\_1 (rev A); Letter from The London Sash Window Company dated 28/04/2023.

The Council has considered your application and decided to grant permission subject to the following condition(s):

Condition(s) and Reason(s):

1 The development hereby permitted must be begun not later than the end of three years from the date of this permission.

Reason: In order to comply with the provisions of Section 91 of the Town and Country Planning Act 1990 (as amended).

2 The development hereby permitted shall be carried out in accordance with the

following approved plans: Site location plan, Exis\_Pro\_Front\_Elev (rev A), Exis\_Win\_Type\_1 (rev A), Pro\_Win\_Type\_1 (rev A); Letter from The London Sash Window Company dated 28/04/2023.

Reason: For the avoidance of doubt and in the interest of proper planning.

3 All new external work shall be carried out in materials that resemble, as closely as possible, in colour and texture those of the existing building, unless otherwise specified in the approved application.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policies D1 and D2 of the London Borough of Camden Local Plan 2017, and policies DH1 and DH2 of the Hampstead Neighbourhood Plan 2018.

## Informative(s):

1 Reasons for granting planning permission:

The proposed details would ensure that the replacement timber framed doubleglazed sash windows would match the frame thickness of the existing singleglazed windows, and would also closely match in all other regards, including their design, material, detailing, colour, opening methods and proportions.

In sustainability terms, double-glazed units are noted as having the potential to reduce energy costs, provide more thermal efficiency and insultation, offset the need for powered heating and so help reduce carbon emissions, and allow for passive flow of ventilation in some cases.

Overall, therefore, the proposal would preserve the character and appearance of the host building and wider Hampstead Conservation and Neighbourhood Areas, and is acceptable.

There are no amenity concerns as the proposal involves the replacement of existing windows only.

The site's planning and appeals history has been taken into account when coming to this decision. No objections have been received following statutory consultation.

Special attention has been paid to the desirability of preserving or enhancing the character or appearance of the Hampstead Conservation Area, under s.72 of the Planning (Listed Buildings and Conservation Area) Act 1990 as amended by the Enterprise and Regulatory Reform Act (ERR) 2013.

As such, the proposal is in general accordance with policies A1, D1, D2 and CC1 of the Camden Local Plan 2017, policies DH1 and DH2 of the Hampstead Neighbourhood Plan 2018, the London Plan 2021 and the National Planning Policy Framework 2023.

2 Your proposals may be subject to control under the Building Regulations and/or the London Buildings Acts that cover aspects including fire and emergency escape, access and facilities for people with disabilities and sound insulation between dwellings. You are advised to consult the Council's Building Control Service, Camden Town Hall, Judd St, Kings Cross, London NW1 2QS (tel: 020-7974 6941).

- 3 This approval does not authorise the use of the public highway. Noise from demolition and construction works is subject to control under the Control of Pollution Act 1974. You must carry out any building works that can be heard at the boundary of the site only between 08.00 and 18.00 hours Monday to Friday and 08.00 to 13.00 on Saturday and not at all on Sundays and Public Holidays. You must secure the approval of the Council's Noise and Licensing Enforcement Team prior to undertaking such activities outside these hours.

In dealing with the application, the Council has sought to work with the applicant in a positive and proactive way in accordance with paragraph 38 of the National Planning Policy Framework 2021.
