T1 - Reduce side profile of the Eucalyptus tree overhanging from 10 Nutley Terrace by 1 to 1.5, this is repeat pruning from a few years ago to control the spread of the crown and dropping of endless detritus into 33 Maresfield Gardens.

 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
