Proposed Work:

FRONT GARDEN: 3 x Leylandii (T1) - Prune height & width up to 2.5m & shape.

REAR GARDEN: 1 x Walnut Tree (T2) - Prune height & width up to 2m & shape.

2 x Laurels & Elaeagnus (T3) - Prune height & width up to 2.5m & shape.

1 x Sycamore (T4) - Prune height & width up to 2m & shape.

4 x Cypress (T4) - Prune height & width up to 2.5m & shape.

2 x Leylandii (T5) - Prune height up to 3m, width 1.5m & shape.

5 x Laurels (T6a & T6b) - Prune height up to 2.5m, width 1.5m & shape.

1 x Robinia (T7) - Fell to ground level.

1 x Catalpa (T8) - Prune by up to 2m all around.

The Council has considered your notification of intended works to trees dated 19 February 2024 and does not wish to object.

- 1 This notice is valid for 2 years from the date of this letter or until the work is completed, whichever is the sooner.

- 2 You are advised that the appropriate standards for tree work are set out in BS 3998: 2010. Failure to ensure that the proposed works are carried out to these standards may result in damage to the tree(s) and may result in legal action by the Council.

- 3 Please note that any approval given by the Council does not give an exemption from the requirements to comply with the Wildlife and Countryside Act 1981 (as amended), or any other Acts offering protection to wildlife.
