The Council has considered your application and decided to grant permission subject to the following condition(s):

Condition(s) and Reason(s):

1 The development hereby permitted must be begun not later than the end of three years from the date of this permission.

Reason: In order to comply with the provisions of Section 91 of the Town and Country Planning Act 1990 (as amended).

2 The development hereby permitted shall be carried out in accordance with the following approved document/drawings:

Location Plan, 2023-01: 01, 02, 03

Design & Access Statement

Reason: For the avoidance of doubt and in the interest of proper planning.

All new external work shall be carried out in materials that resemble, as closely as possible, in colour and texture those of the existing building, unless otherwise specified in the approved application.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policy D1 and D2 of the London Borough of Camden Local Plan 2017.

- 4 Prior to commencement of development, full details in respect of the living roof in the area indicated on the approved roof plan shall be submitted to and approved by the local planning authority. The details shall include:
 - i. a detailed scheme of maintenance
 - ii. sections at a scale of 1:20 with manufacturers details demonstrating the construction and materials used
 - iii. full details of planting species and density

The living roof shall be fully provided in accordance with the approved details prior to first occupation and thereafter retained and maintained in accordance with the approved scheme.

Reason: In order to ensure the development undertakes reasonable measures to take account of biodiversity and the water environment in accordance with policies CC1, CC2, CC3, D1, D2 and A3 of the London Borough of Camden Local Plan 2017.

Informative(s):

1 Reasons for granting permission:

Planning permission is sought for the addition of a single storey, flat roofed side extension at the rear of the existing single storey rear wing. A courtyard will be formed between the proposed extension and the rear elevation of the main building.

There are other similar single storey side extensions at the rear of other neighbouring properties on this side of Princess Road, i.e. at nos. 22 and 34. Although these extensions pre-date the currently adopted Local Plan, they define the character and appearance of the rear of the terrace to a certain extent.

Additionally, given the high boundary walls at the site (which would prevent the proposal from being visible from ground floor level at adjoining sites) and given the proposal to form a green roof, it is not considered that the proposal would result in an inappropriate or excessive form of development which would

detract unduly from the significance of the Conservation Area.

Details of the species and maintenance of the green roof should be secured by a planning condition.

The Primrose Hill Conservation Area Advisory Committee has raised no objections.

Special attention has been paid to the desirability of preserving or enhancing the character or appearance of the Conservation Area, under s.72 of the Planning (Listed Buildings and Conservation Areas) Act 1990 as amended by the Enterprise and Regulatory Reform Act 2013.

As the proposal would site below the existing rear wing to which it would be attached, and only 300m above the boundary wall with no. 24, it would not result in any undue overshadowing at any neighbouring sites. Furthermore no new windows or areas are proposed which would result in any undue overlooking of any neighbouring rooms or gardens and, due to its height and appearance, it would not result in any overbearing effects or loss of outlook for any neighbouring occupiers.

No objections have been received prior to making this decision. The planning history of the site has been taken into account when coming to this decision.

As such, the proposed development is in general accordance with policies A1, D1 and D2 of the Camden Local Plan 2017. The proposed development also accords with the London Plan 2021 and the National Planning Policy Framework 2023.
