### **NO OBJECTION TO SECTION 211 NOTICE OF WORKS TO TREE/S IN A CONSERVATION AREA**

Proposed Work:

FRONT GARDEN: 1 x Olive (T1) - Reduce size of crown height and spread by 1.5m. Reduce 50% of live branches, entire canopy.

1 x Sambucus (T2) - Reduce size of crown height and spread by 0.5m - 1m. Reduce all live branches, 0.5m - 1m length reduction, entire canopy.

REAR GARDEN: 1 x Acacia (T4) - Pollard back to previous pruned points. Remove all live branches, 2m - 3m length reduction, entire canopy.

4 x Hornbeams (TG5) - Reduce size of crown height and spread by 0.5m - 1m. Reduce all live, declining, diseased, interfering, over-extended branches, 0.5m - 1m length reduction, entire canopy.

1 x Hawthorn (T6) - Reduce size of crown height and spread by 1m - 2m. Reduce all live, over-extended branches, 1m - 2m length reduction, entire canopy.

The Council has considered your notification of intended works to trees dated 05 March 2024 and does not wish to object.

- 1 This notice is valid for 2 years from the date of this letter or until the work is

completed, whichever is the sooner.

- 2 You are advised that the appropriate standards for tree work are set out in BS 3998: 2010. Failure to ensure that the proposed works are carried out to these standards may result in damage to the tree(s) and may result in legal action by the Council.
- 3 Please note that any approval given by the Council does not give an exemption from the requirements to comply with the Wildlife and Countryside Act 1981 (as amended), or any other Acts offering protection to wildlife. Of particular note is the protection offered to bats, birds and their nests from construction works.
