Proposed Work:

FRONT GARDEN: 1 x Olive (T1) - Reduce size of crown height and spread by 1.5m. Reduce 50% of live branches, entire canopy.

1 x Sambucus (T2) - Reduce size of crown height and spread by 05m - 1m. Reduce all live branches, 0.5m - 1m length reduction, entire canopy.

REAR GARDEN: 1 x Acacia (T4) - Pollard back to previous pruned points. Remove all live branches, 2m - 3m length reduction, entire canopy.

4 x Hornbeams (TG5) - Reduce size of crown height and spread by 0.5m - 1m. Reduce all live, declining, diseased, interfering, over-extended branches, 0.5m - 1m length reduction, entire canopy.

1 x Hawthorn (T6) - Reduce size of crown height and spread by 1m - 2m. Reduce all live, overextended branches, 1m - 2m length reduction, entire canopy.

The Council has considered your notification of intended works to trees dated 05 March 2024 and does not wish to object.
