GRANT CONSENT FOR WORKS TO TREE/S UNDER A TREE PRESERVATION ORDER

Proposal:

(TPO REF. 26H-G1) EAST SIDE OF GROUNDS: 1 x Horse Chestnut (T1) - Raise crown to 5m over the road and pavement. Final pruning cuts less than 7cm diameter.
(TPO REF. 26H-T23) 1 x Ash (T2) - Remove small branch hanging over pavement to provide clearance from the pavement. Final pruning cuts less than 7cm diameter.
(TPO REF. 26H-T22) 1 x Ash (T3) - Remove small branch hanging over pavement to provide clearance from the pavement. Reduce branches growing over the cricket nets by 2.5m, back to previous cuts where applicable. Final pruning cuts less than 7cm diameter.

The Council has considered your application dated 06 March 2024 and decided to grant consent subject to the following condition(s):

Conditions and Reasons:

- 1 This decision is valid for 2 years from the date of this decision or until the work is completed, whichever is the sooner.

Reason: To allow the Local planning authority to monitor the completion and

standards of the work.

- 2 All work shall be carried out in accordance with the relevant recommendations of British Standard 3998: 2010. (Recommendation for Tree Work)

Reason: To ensure the preservation of the amenity value and health of the tree(s).

- 1 Please note that any approval given by the Council does not give an exemption from the requirements to comply with the Wildlife and Countryside Act 1981 (as amended), or any other Acts offering protection to wildlife.
