About Camden

Our portfolio includes hostels for families and for single people, those with mental health problems, young people and people with physical and / or learning disabilities. We also manage two small Travellers' sites. We also have a large portfolio of individual self-contained furnished properties located throughout the borough. We have an ambitious programme of developing new hostels and acquiring and developing more self-contained accommodation.

By providing a comprehensive portfolio of good quality temporary accommodation located in Camden, we can help to address the needs of those in greatest need in our community and help us provide a better future for all.

About the role

The Environment Team Manager will play a vital role in helping us to provide furnished temporary homes for some of the most vulnerable residents in our community. We want to ensure that the homes we provide are safe, secure, clean and suitable for their different needs. In this role, you will be helping to address the needs of the most vulnerable and in greatest need in our community, improve their housing situation, and help us achieve a fairer, better future for everyone in Camden.

This is an operational role, and you will work closely with other staff teams, internal and external contractors, and other service providers to ensure the effective delivery of a range of building related services across the portfolio, and the delivery of building works and maintenance. You will take the lead on ensuring that all building related services provided are in line with health and safety and fire safety legislation and ensure that the relevant inspection regimes are carried out and appropriately recorded. You will ensure that the hostel environment is kept clean and safe for residents and staff by managing the front line cleaning service in line with COSHH and other relevant legislation, and that risks are assessed and appropriate mitigations implemented. The role will also take the lead in building related emergency situations, liaising

with other departments and colleagues to ensure that the issues are addressed and resolved. You also will be instrumental in setting up of new schemes and closing down of old schemes.

You will lead on liaising with our void teams to ensure that all the necessary works to our void properties are completed, and then arrange for them to be furnished and made ready to move into in a timely manner, to ensure a ready supply of accommodation in the borough for those that are urgently in need of housing.

This is a front line role and you will be working with client groups that may have complex needs and exhibit challenging behavior. You will need to demonstrate a thorough understanding of, and empathy for, our client group and the issues that they experience.

About you

Essential:

You will be responsible for delivering a customer focused service, with particular emphasis on the control and management of health and safety and fire safety issues across our portfolio. This will require an enhanced knowledge of the relevant legislation, of our responsibilities and of the statutory requirements specific to the residential and working environments and the client groups, so that we can ensure that our buildings are compliant, and residents and staff are safe.

You will need experience of working with a wide range of stakeholders, including internal providers, external services and contractors to ensure the effective delivery of building related works and maintenance, building improvement, and a range of other building and facilities related services are delivered effectively. This will include regular checks to ensure that all of our statutory servicing regimes are being carried out and that remedial works are completed.

You will need to understand the importance of getting empty properties ready to let as soon as possible and the ability work with others to achieve this.

You will need the knowledge and ability to carry out and advise on risk assessments for a variety of situations and people relative to the role and environment.

You will need the skills and experience to manage a front line cleaning service, including training, coaching, supervision and performance management, and ensure that staff observe safe working practices in accordance with all relevant legislation.

As a manager based on site, you will need to be able to work independently and unsupervised, and as part of a team with other staff teams based on site.

You will need to be flexible, and able to reassess priorities at short notice in response to changing circumstances.

We provide services for some of the most vulnerable people in our community. This includes families with children, young people, those with a history of rough sleeping, those with mental health problems and those with substance misuse issues. Some of our clients may also present with challenging behaviors. You will need to demonstrate and thorough understanding of, and empathy for, our client groups and the issues that they experience. You will also need to demonstrate the ability to interact with them in a positive and non-judgmental way, and have the skills and ability to manage challenging interactions effectively.

Desirable

You will either have, or be willing to train and undertake a relevant Health and Safety and / or Fire Safety training and qualification e.g. NEBOSH general certificate or equivalent or other relevant recognised training and qualifications relevant to the role.

Practical knowledge of the requirements of setting up new schemes and of closing down schemes would be desirable.

Work Environment:

You will be based in one of our hostels but will be managing a portfolio of properties located around the borough. Our portfolio includes hostels for families and for single people, those with mental health problems, young people and people with physical and / or learning disabilities. We also manage two small Travellers' sites. We also have a large portfolio of individual self-contained furnished properties located throughout the borough

You will be required to travel between sites, and will be required to attend our main offices in 5 St Pancras Square as required.

You may be lone working at times when you are visiting the dispersed properties around the borough,
