Sycamore (T1): Reduce SE aspect of crown 1m below previous points & remainder of crown back to previous points (1-2m)

Work is to mitigate damage arising from excessive debris falling on to neighbouring glass roof and guttering and to protect the health and stability of trees to be retained on the site ensuring that a satisfactory standard of visual amenity is provided and maintained. All specified work is within good arboricultural practice and husbandry.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

Where trees are protected by a Tree Preservation Order, please number them as shown in the First Schedule to the Tree Preservation Order where this is available. You should use the same numbering on your sketch plan (see below for sketch plan requirements).

- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
