Secondly, the impact on the character and appearance of the area appears to be neutral; in fact, there is arguably an enhancement due to the removal of the street parking bay which opens up the space in front of the house allows for better views of the houses from the street. Finally, the removal of the street petrol parking bay and replacement with an electric car driveway is advantageous in reducing congestion and pollution in the street and community, which is beneficial for air quality and community standards of living. Keeping Condition 4 would reverse these aforementioned benefits; therefore, we are in favour of removal of Condition 4.
