- T1 poplar stump (0.5m) take down to ground level.

 T2 cypress tree (10m) take down to ground level.

 T3 cypress tree (3m) take down to ground level.

 T4 cypress tree (2m) take down to ground level.
 - T5 cypress tree (6m) take down to ground level.

 T6 mahonia tree (2m) take down to ground level.
 - T7 bay tree (6m) reduce overhanging branches back to boundary, approximately 2m reduction and take down two shoots from roots by fence to ground level.
 - T8 forsythia tree (2m) take down to ground level.
 - T9 willow tree (8m) take down to ground level.
 - T10 sycamore tree (8m) take down to ground level.
 - T11 yew tree (2m) take down to ground level.
 - T12 elder tree (2m) take down to ground level.

Reason for work and proposed re planting-

The root system of the existing trees have grown too large, causing damage to the existing structure, which is responsible for retaining all the soil and the area above it. The roots are also exhausting the surrounding area, causing significant damage.

Our plan is to replace the trees according to a new planting scheme that includes a row of Evergreen Pleached trees, such as Photinia Red Robin or Magnolia Grandiflora. We believe both options have stable and sensible root growth and will bring more visual appeal and light to the garden.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
