Details of the pre-application advice received

The railings would be 0.9m high from the parapet. Metal railings are supported over other styles of barrier as railings are part of the nineteenth century architectural palette of details and marry with the architectural style of the host property.

The scheme proposes 3 new rooflights, laid out to align with the historical window elevations. Rooflights are a common feature in Lawford and Patshull Road and given the shallow roofline they would not be largely viewable from the street scene. The scale, siting of the rooflights would be acceptable and would appear as subordinate additions on the roof. Conservation style rooflights would be encouraged.

On balance, due to the precedence being set for roof terraces in the immediate vicinity, the size of the terrace and the material of the railings it is considered that proposal would, on balance, be acceptable in terms of design.

It is considered the proposed development for the roof terrace could be acceptable.
