Rear Garden: T1: Mature Cherry: Approximately 20.00m: Remove the left hand stem (secondary) to a point. Approximately 0.50 -1.00m above the included union with the main stem. Remove major dead wood throughout crown. Reasons:

Mature twinned stemmed tree growing close to the boundary walls has a lean toward and over the garden studio.

Longitude, historic wound near to ground level, approximately 1.00m long (partially occluded).

Obvious signs of basal decay.

Fungal fruiting body noted (likely Ganoderma).

Tree has an extensive included union from approximately 1.80m above ground level.

Secondary stem lean and growing over studio roof.

Works to relieve weight burden and wind sail area, prevent potential split out from included union.

We wish to retain this fine tree as long as possible.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
