T1: Ash. This tree needs to be cut back from the building (house) by approximately 3 metres to align with parts of the tree that are not touching the house. It is NOT a 3 metre reduction all round but only in places where the tree is touching the house (see pics). It will help to create a good clearing between the house and the tree whilst maintaining the balance of the tree. Overlong branch will be reduced to lessen weight (see pics)

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
