The architectural integrity of a listed building will be seriously damaged by these plans as this building would no longer primarily be a place of entertainment but yet another anodyne hotel (proposed operator Citizen M). It will lose all the internal theatre features that it still has, including the stage house and the scenery systems. There is also a serious risk to the integrity of this listed building as it will only retain the front façade and some parts of the external side walls intact.
