#### **NO OBJECTION TO SECTION 211 NOTICE OF WORKS TO TREE/S IN A CONSERVATION AREA**

Proposed Work:

FRONT GARDEN: Group of Birch (G1) in North-East Section of planter (G1) - Thin crown density by approx. 15%, removing suppressed, crossing or dying branches. Tip prune to reduce by approx. 30cm - 50cm. Reduce lateral and sub lateral growth up to approx. 30cm - 50cm to tidy and balance.

Group of Birch in South-West Section of planter (G1) - Reduce crown heights by approx. 1.25m. Thin crown density by 20%, removing suppressed, crossing and dying branches. Reduce lateral and sub lateral growth by up to approx. 1m to control encroachment.

1 x Mimosa (T1) - Reduce crown by approx. 1m - 1.25m. Thin crown density by approx. 20%.

The Council has considered your notification of intended works to trees dated 09 April 2024 and does not wish to object.

- 1 This notice is valid for 2 years from the date of this letter or until the work is completed, whichever is the sooner.
- 2 You are advised that the appropriate standards for tree work are set out in BS 3998: 2010. Failure to ensure that the proposed works are carried out to these

standards may result in damage to the tree(s) and may result in legal action by the Council.

- 3 Please note that any approval given by the Council does not give an exemption from the requirements to comply with the Wildlife and Countryside Act 1981 (as amended), or any other Acts offering protection to wildlife. Of particular note is the protection offered to bats, birds and their nests from construction works.
