We are applying for the following tree works:
To reduce the height of the Paper Birch tree in the rear garden by up to 2m (reducing the new growth that has taken place since its last hard pruning 4 years ago). To reduce the height of the Bay Tree in the font garden by up to 2m (this tree has never had hard pruning).
These works are to allow more light into the nearby properties and gardens.
You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work. Where trees are protected by a Tree Preservation Order please number them as shown in the First Schedule to the Tree Preservation Order where

this is available. You should use the same numbering on your sketch plan (see below for sketch plan requirements).

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
