G1: Stand of 15 x Birch Trees: Approximately 9.00m: Thin crown density throughout by approximately 15%-20%. Reduce lateral and sub lateral growth encroaching over boundary by approximately 1.20m. Reduce crown heights by approximately 1.20m. General maintenance. T1: Mature Japanese Maple: Approximately 6.00m: Thin crown density evenly throughout by approximately 6.00m: General maintenance.

T2: Cercis: Approximately 5.00m: Thin crown density by approximately 15%-20%. General maintenance.
