The proposal is for the addition of the AHU units on Rowland Hill street, on the side of the hospital, at the edge of the street, on the bay between where the entrance to the underground parking to Pears Building is located, and where currently there is a timber enclosure. These AHUs are needed to comply with the current HTM regulations that each theatre should be receiving a certain minimum amount of air changes. Currently with the existing ventilation equipment, this number of air changes can not be achieved which has resulted in the closure of one of the theatres. It is proposed that this AHU unit will be in place for a maximum of 2 years. This will allow the theatre that is currently closed (as a result of not complying with the said HTM) to be reinstated and functional, and enable the Trust to use it.
