#### Occupied property discounts or exemptions

The Council Tax full rate is based on the assumption

that two or more adults live in the property. Be sure to tell us

who lives in your household, so you pay the right amount

-If you are the only adult aged over 18 living in your household,

you can apply for a 25% Single Person Discount

If you or any member of your household is

-a full time student, you may not need to pay the Council Tax

or you may be able to pay less. To apply, send us a current full time certificate from your place of study.

-severely mentally impaired, download a copy of our application form or let us know and we will send you a form.

-disabled and your home has been adapted because of this, you can apply for Disablement Relief. If your claim is

successful, your Council Tax will be charged at the band below yours.



#### Unoccupied property discounts or exemptions

If your property becomes unoccupied, let us know if the property is furnished, unfurnished or uninhabitable.

If the property is unoccupied and also:

-furnished, you must tell us, however no discount applies.

-unfurnished, you may be able to pay no Council Tax for up to 1 month.

-unfurnished and uninhabitable, you may be able to apply for a 25% discount

Don't delay telling us as we may need to arrange for a Council Tax Inspector to visit the property to confirm your request.

#### Premium

If your property remains empty for over two years, your Council Tax will double (a premium of 100%) and in future years this will increase further.

### Council Tax Support

This can help to reduce all or some of your Council Tax if you are on a low income and have savings under £16,000.
