Crown reduction to London Plane cut crack general prune length up to not exceeding 4m in length from new growth tips to not exceed or breach the recommended wound diameter of 70mm

One London Plane tree to reduce volume by approx 4m in length ,general prune away to clear roof line of buildings.

Lift lower parts of crown over public highway .

Any crown parts growing rogue from tree form to reduce to form crown shape .

  - marking all trees on the plan, but only numbering those to which you want to carry out work
  - $\circ\;$  showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)
