The Euston Town BID has been consulting with traders and residents along Chalton Street and with Camden Council officers. Consultees have highlighted challenging trading conditions and a lack of identity and visibility of the street. Euston Town BID have responded with proposals to replace a faded signboard at the southern end of the street with new creative gateway signage.

The new sign will: [1] replace the current outdated sign with a new dynamic design that is both promotional and creative; [2] help to draw footfall by signalling the interesting and appealing destination of Chalton Street; [3] introduce a unique placemaking element over which businesses and residents have a sense of ownership.

The proposal uses a changeable signage system that signals passers by the direction of Chalton Street, the Chalton market day and the businesses that populate the street. The sign also uses an illuminated directional pointer. The the sign is powered by a single solar panel and is energy independent.
