Proposal:

(TPO REF: C1241 2020) REAR GARDEN: 2 x Horse Chestnut (TG1) - Crown reduction of 25% removing no more than 2.5m in height and 1m lateral growth to shape, retaining all internal growth and pruning all growth to suitable growth furniture in accordance with BS3998.
1 x Lime (T2) - Crown reduction of 25% removing no more than 3m in height and 2m lateral growth to shape (to be uniform with TG1 once pruned). Retain all internal growth and pruning all growth to suitable growth furniture in accordance with BS3998.

The Council has considered your application dated 18 April 2024 and decided to grant consent subject to the following condition(s):

Conditions and Reasons:

- 1 This decision is valid for 2 years from the date of this decision or until the work is completed, whichever is the sooner.

Reason: To allow the Local planning authority to monitor the completion and standards of the work.
