Externally the front garden will be reconfigured to accommodate two lightwells, which will serve the lower ground floor and provide a fit for purpose refuse storage area. Windows generally will be replaced, with a new sash window being proposed on the south elevation and the windows to the extension being reconfigured. The extension will be re-rendered with its balcony and stair to be replaced with one of a reduced scope. External landscaping upgrades are proposed to the front and rear gardens.

Details of the pre-application advice received

The determination of the planning application was assessed on three accounts, heritage and design, basement works and amenity. The preapplication advice required a few amendments to the design and providing these were implemented the proposal would be considered acceptable. Listed below is a summary of each of these considerations and how the proposal has addressed the required amendments.

Heritage and design (Policy context) - All development should seek to preserve or enhance the character and appearance of that conservation area.

Heritage and design (Works to front) - The proposed lightwells are considered acceptable as there is already precedent for them on the street. However, they should not vastly differ in any significant manner to the already approved neighbouring lightwells and secondly, they should be designed with a discrete metal grill. An increased bin storage area is acceptable providing it is proven that the current design is inadequate, and they remain concealed by the hedge. The proposal as required allows for lightwells of a similar scale to neighbouring properties complete with metal grills and fit for purpose bins stores with a retained street hedgerow.

Heritage and design (Works to rear) - The existing two storey, partial width extension, although not considered to be of merit, forms part of the character of the buildings. A full-width extension would not be deemed acceptable. Furthermore, the south-east facades of the extensions are characteristically heavily glazed on the lower floor with smaller windows on the upper floor and so read as two floors. There is no objection to having a double height space internally, but it cannot be read as a double height space externally to respect the scale, rhythm, proportion, and character of the rear of these building as a group. French doors must be reinstated to reflect the multi-pane nature of the upper sashes. The proposal as required works with the existing extension only. Windows have been curated to ensure the extension reads as if it has two floors. The existing metal French door is to be refitted with a traditional multi-pane system.

Basement works - Basement development will only be considered providing it is supported by sufficient technical information. The basement level works require a Basement Impact Assessment to assess the impact of the works on drainage, flooding, groundwater conditions and structural stability. The application as required is supported by a Basement Impact Assessment.

Amenity - The proposed pre-application design with the side infill extension and terrace located to the north of the existing extension would not be acceptable for concerns relating to the overlooking of 14 Kidderpore Gardens. The proposal as required omits the extension and terrace proposed in the pre-application and instead proposes a reduced in scope new balcony.
