## Description of Proposed Works

Please describe the proposed works

I would like to replace the white wood framed bi-fold glass doors on top floor balcony (front of the property) with white aluminium framed glass bi-fold doors, retaining the existing dimensions, specification, number of panels, and general appearance. They will look basically identical, especially from the street given they are on the top (third) floor. I have even specified white seals/gaskets to match the existing ones. The wooden doors have weathered badly and have failed, causing significant water damage inside the property and need to be replaced. I would like to replace them with something that will hold up better in the wind and rain whilst keeping the external look of the property exactly the same. There is precedent on the terrace for aluminium bifold doors. Number 22 has grey powder coated aluminium doors, and number 16 also. I am proposing to keep the same white colour to retain a more traditional look.
