IN GROUNDS SEE MAP: 1 x Cherry (T1) - Prune back from building to give 1m clearance.
Crown lift to 3m.

1 x Maple (T2) - Prune back from building to give 3m clearance. Crown lift to 3m.

1 x Cherry (T3) - Crown reduce 2m back to old pruning wounds around crown break.

1 x Cherry (T4) - Crown Lift to 3m.

1 x Maple (T5) - Crown Lift to 3m.

1 x Hawthorn (T6) - Crown Lift to 3m. Prune epicormics and crossing branches.

1 x Hawthorn (T7) - Crown Lift by or to 3m. Prune epicormics and crossing branches.

1 x Sorbus (T8) - Crown reduce 2m.

1 x Sorbus (T9) - Crown reduce 2m.

1 x Sorbus (T10) - Crown reduce 2m.

The Council has considered your notification of intended works to trees dated 24 April 2024 and does not wish to object.
