REAR GARDEN: 1 x Birch (T1) - Overall crown reduction by up to 2.5m branch lengths.  
1 x Apple (T2) - Fell to ground level.  
1 x Apple (T3) - Overall crown by up to 1.5m branch lengths.  
1 x Laurel (T5) - Fell to ground level.  
1 x Sycamore (T6) - Overall crown reduction by 2m - 3m branch lengths.

The Council has considered your notification of intended works to trees dated 02 May 2024 and does not wish to object.
