### Proposal:

Replacement of single-glazed timber frame windows on front, side and rear elevations at 2nd floor level with double-glazed box sash windows.

The Council has considered your application and decided to grant permission subject to the following condition(s):

## Condition(s) and Reason(s):

1 The development hereby permitted must be begun not later than the end of three years from the date of this permission.

Reason: In order to comply with the provisions of Section 91 of the Town and Country Planning Act 1990 (as amended).

The development hereby permitted shall be carried out in accordance with the following approved plans: (1296 - BPG-)ESLP-001, EBP-001, EP-001, AE-001, AE-002, AE-003, AE-004; Design and Access Statement from Nicholas Lee Architects Ltd. dated March 2023.

Reason: For the avoidance of doubt and in the interest of proper planning.

All new external work shall be carried out in materials that resemble, as closely as possible, in colour and texture those of the existing building, unless otherwise specified in the approved application.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policies D1 and D2 of the London Borough of Camden Local Plan 2017.

# Informative(s):

1 Reasons for granting planning permission:

The proposal involves the replacement of single-glazed timber frame windows on front, side and rear elevations at 2nd floor level with double-glazed, timber frame box sash windows. The replacement windows are considered to be acceptable in terms of their design, material, colour and proportions, such that, the character and appearance of the host building and wider Belsize Conservation Area would be preserved.

The proposal includes alterations in the design and opening methods of some existing side hung casement and central pivot windows; however, the replacement with sliding box sash units is considered to be appropriate and would provide consistency in form and visual appearance, in keeping with the character of the host and similar buildings within the wider streetscene.

While there would be some degree of increased thickness to frames in order to accommodate double-glazed panes, in this instance, the proposed use of suitably designed units are considered to be an appropriate and sympathetic change.

In sustainability terms, double-glazed units are also noted as having the potential to reduce energy costs, provide more thermal efficiency and insultation, offset the need for powered heating and so help reduce carbon emissions, and allow for passive flow of ventilation in some cases.

The replacement and addition of a single, white painted safety bar in front of each window would not result in any noticeable difference in appearance at the host building, particularly given the upper floor level position of windows, the addition to the lower part of each window only and the white colour of the bars; similar to a number of existing safety rails of this type already in situ at the property.

There are no amenity concerns as the proposal involves the replacement of existing fenestration in the same positions.

The site's planning and appeals history has been taken into account when coming to this decision. Consultation responses were received from the Belsize Conservation Area Advisory Committee and Belsize Society following statutory consultation. These have been taken into consideration and are recorded in the associated consultation summary sheet. No objections have been received.

Special attention has been paid to the desirability of preserving or enhancing the character or appearance of the Belsize Conservation Area, under s.72 of the Planning (Listed Buildings and Conservation Area) Act 1990 as amended by the Enterprise and Regulatory Reform Act (ERR) 2013.

As such, the proposal is in general accordance with policies A1, D1, D2 and CC1 of the Camden Local Plan 2017, the London Plan 2021 and the National Planning Policy Framework 2023.
