T1 Sycamore tree. Large spreading tree: 25m high by 18m spread at rear of modest sized rear garden, overhanging several neighbouring gardens creating excessive shade.

Crown thin by 30%. Reduce height by 2.75-3m. Reduce lateral spread by 2-2.5m. Reshape accordingly.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
