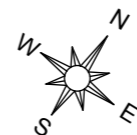


**NOTES:**

- 1.- Partition wall to be moved by 600mm.
- 2.- Removal of chimney breast TBC by client.
- 3.- Utility cupboard.
- 4.- New staircase to loft.
- 5.- Existing chimney breast to be removed.
- 6.- Existing door to be re-hung.
- 7.- New door to replace existing window. Style to match existing fenestration.
- 8.- New external fireplace.
- 9.- New terrace on existing roof.
- 10.- Existing rooflight to be removed.
- 11.- Existing railing to be replaced with new traditional metal balustrade.
- 12.- New brickwork parapet (1m high from proposed terrace level) with 0.5m high timber panelling on top to act as a side privacy screen to both sides of the terrace.
