Due to various damp ingress issues, the roof level box gutter needs to be stripped up and replaced with a new waterproof system.

Along the box gutter there are two door openings, which prevent the necessary waterproof up-stands being formed, the doors therefore need to be removed and replaced with windows, so that the necessary upstands can be formed.

The 2.no roof level upvc single doors will be stripped out and replaced with 2.no upvc windows to match the other existing windows in design. The lower section of the opening will be rasied as a new insulated wall and will be finished with the liquid applied waterproof finish which is proposed to the main box gutter.
