Removal of railings on north and south side of entrance to facilitate stripping of steps back to the original underlying (badly leaking) Portland Stone slabs. Lay impermeable membrane to stop water ingress to basement and recover with new Portland Stone. Replacing badly worn door threshold with new Portland stone to match. Refurbish and replace original railings. Remove and refurbish and replace remaining original railings. Remove badly damaged upstand on south side of entrance and also along pavement.
