1. False Acacia - Removeand Replace
I am mindful that this tree was involved in the agreement between London Borough of Camden and myself in connection with the wrongful
removal of certain trees (not by my company nor on my instruction). The resolution of this matter included the retention of this false acacia tree. My client's proposal is now to remove it and replace it. Accordingly I am proposing that a red oak (Quercus rubra) 18-20cm girth is
planted near the location of this tree, probably set forward a little, away from the boundary. This is a vigorous tree, typically of high vitality in

this area, and should make a positive contribution to the Conservation Area within a few years

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
