Entrance door to flat A, is 42 cm below the pavement level. We intend to have a gradually inclined area from the pavement to the front door of our flat, to allow for a wheel chair access. Finished surface of this area will be paved with none slip natural stone, linear setts, of grey and buff colours. There is no change of use.

A continuous galvanized drain channel, will be provided before the entrance door, and connected to the existing gully.

Our neighbours at 160, 162, 164 and 170, Haverstock Hill, have done exactly the same. Different paving materials have been laid in those areas by our different neighbours.

In our email of 20 February 2024, to Mr. Nick Baxter, we mentioned that car port areas of houses on our side of Haverstock Hill, like numbers 160, 162, 166, 170, and so on, have been resurfaced and directly slopped from the pavement to the front doors of those flats, thus allowing parking for more than one car.

We said that, we would like to follow our neighbours and similarly slope our carport area, directly from the pavement to our entrance door and resurface that area with none slip natural stone pavers. That would provide us with a WHEEL CHAIR ACCESS to our flat and the possibility of parking for two cars, instead of one.

In Mr. Nick Baxter's response email of 12 April 2024, at 14:16, we were informed that we need planning permission.
