Goals:

- · Remove disease dead wood
- Massaria inspection Remove dead, diseased branches as needed, entire canopy

T5 Maple group left side front of property

Remove disease dead wood

- · Remove dead branches as needed, entire canopy
- T6 Lime left front of property

Goals:

- · Remove disease dead wood
- · Reduce size of crown height and spread
- · Remove dead branches as needed, center of canopy

London Plane, Platanus x acerifolia rear play area

Goals:

- · Pollard back to previous pruned points
- Reduce all live branches, 2-3 metres length reduction, entire canopy

T8 Maple left side of astro court

Goals:

- Reduce spread of tree by pollarding back to previous pruned points growing towards fence to give clearance
- Reduce live branches as needed, 2-2.5 metres length reduction, growing toward fence

TG9 Lime X2 group back of property neighbouring garden

Goals:

- · Reduce spread of crown by trimming back
- Reduce live, over-extended branches as needed, 1-2 metres length reduction, entire canopy by trimming back

T11 Purple leaf Maple right side of property neighbouring tree

Goals:

- · Reduce spread of crown
- Reduce live, over-extended branches as needed, 1-2 metres length reduction, growing toward School property

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
 - o mark and name surrounding roads
 - o sketch in buildings, including adjoining properties
 - o add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
