T1- Maple tree- (8m)- crown reduction of up to 3m on all aspects of tree.
T2-Cypress tree- (12m) - reduce height by approximately 2.5m and lift crown to approximately 4m from ground level. Prune in sides by up to 1m whilst maintaining live foliage.

T3- Elder tree- (4m)- crown reduction of approximately 1.5m.
