Proposed Work:

SIDE GARDEN: 1 x Horse Chestnut (T1) - Crown reduction back to previous pruning points by removing approx. 1.5m from all over.

1 x Sycamore (T2) - Crown reduction back to previous pruning points by removing approx. 1.5m from all over.

REAR GARDEN: 1 x Horse Chestnut (T4) - Fell as close to ground level as possible and treat with one application of glyphosate only, to prevent regrowth.

1 x Horse Chestnut (T5) - Crown reduction by removing approx. 3m from height and 2m from sides, pruning to suitable growth points.

1 x Horse Chestnut (T6) - Crown reduction by removing approx. 3m from all over pruning to suitable growth points.

The Council has considered your notification of intended works to trees dated 10 April 2024 and does not wish to object.

- 1 This notice is valid for 2 years from the date of this letter or until the work is

completed, whichever is the sooner.

- 2 You are advised that the appropriate standards for tree work are set out in BS 3998: 2010. Failure to ensure that the proposed works are carried out to these standards may result in damage to the tree(s) and may result in legal action by the Council.
- 3 Please note that any approval given by the Council does not give an exemption from the requirements to comply with the Wildlife and Countryside Act 1981 (as amended), or any other Acts offering protection to wildlife.
