Details for Condition 3 (Order hatch and door) for planning reference 2023/2472/L dated 02/02/2024 for 'External facade alterations including new order point replacing current large window, and replacement louvre extract to upper floor window. Internal fit out including new front of house space, new internal partition wall to hide stairs, internal mural and new water, electrical and mechanical systems.'

1 Reasons for granting permission:

Condition 3 requires detailed drawings of the order hatch and entrance door be submitted to and approved by the Council. The applicant has provided elevation and section drawings that demonstrate the materiality and dimensions of the entrance door and access hatch.

The entrance door would be red grandis hardwood with a brass finish measuring 2.4m high. The proposed order hatch would be constructed of the same red grandis hardwood with brass finishings. Both elements are considered to respect the appearance of the host property. These details conform with the proposed plans and would be appropriate in the context of the host building, the wider streetscene, and the surrounding conservation area. The provided details would preserve the character and appearance of the Seven Dials Conservation Area. As such, the provided detailed drawings are considered sufficient to discharge condition 3.

The full impact of the proposal was assessed as part of the determination of the original application, reference 2023/2472/L.

As such, the details are in accordance with the requirements of Policies D1 and D2 of the London Borough of Camden Local Plan 2017.
