T1 - Lime: dbh 55cm; Too large for site, within 2m of building/wall, wounds, basal growth, dead wood; Crown reduce 2-3m, remove basal growth, and deadwood.

TG1 - Ash x3: dbh 60cm; Impacting wall, too large for site, within 2m of building; Crown reduce 6m in height and 2-3m in spread.

T2 - Ash: dbh 25cm; Impacting wall, too large for site, within 2m of building, weak fork, would/canker, poor stem taper, compression fork; Fell.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
