6 weeks notice to fell a multi-stemmed self-seeded Ash on the West side. The root purchase is poor, resulting in one or the other stem falling over in the past. The tree is growing over a grave site that has been reclaimed by the owner and therefore needs to be felled. It also has signs of Ash die back with lots of epicormic growth

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - $\circ\;$ adding other relevant features on the site (e.g. greenhouse, paths)
