The tree is a plum tree (Prunus domestica), 4 m in height, 2-3m in spread. The tree is to be felled. It is growing into the much larger magnolia tree and at angle that makes it unstable. It is supporting itself on the metal staircase. The garden will be planted with at least 13 new trees.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
