(TPO REF: C396-T2 to T5) FRONT GARDEN:

1 x Lime (T1) - Re-pollard by 5m back to previous points.

1 x Lime (T2) - Re-pollard by 2m back to previous points.

2 x Purple Leaf Plums (T3 & T4) - Reduce back by up to 2m back to previous points.

The Council has considered your application dated 11 May 2024 and decided to grant consent subject to the following condition(s):

Conditions and Reasons:

- 1 This decision is valid for 2 years from the date of this decision or until the work is completed, whichever is the sooner.

Reason: To allow the Local planning authority to monitor the completion and standards of the work.

- 2 All work shall be carried out in accordance with the relevant recommendations of British Standard 3998: 2010. (Recommendation for Tree Work)

Reason: To ensure the preservation of the amenity value and health of the tree(s).
