G1-Row 3x Bay(Laurus nobilis)
-reduce height of ALL trees by up to 2m from tips in level line with roof height
-trim back from face to match lower section(trimmed by client)
To reduce wind sail during high winds
T1-Lawson's Cypress(Chaemcyparis x lawsoniana)

-from ground level using tall stem ladder, trim back all side growth to shape and tidy

-crown lift ensuring low branches up to 0.5m above head height

For general maintenance and greater separation from building

In neighbouring property No.12 Pilgrims Lane

G2-Large Beech(Fagus)+Cypress(Cupressus)

-cut back ALL overhanging branches encroaching on No.10 building back to boundary line to allow 1.5m separation to create more light on No.10 aspect and avoid excessive leaf drop into gutters

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
