The development hereby permitted must be begun not later than the end of three years from the date of this permission.

Reason: In order to comply with the provisions of Section 91 of the Town and Country Planning Act 1990 (as amended).

The development hereby permitted shall be carried out in accordance with the following approved plans: 0437 21 002 Rev. A; 0437 21 102 Rev. A; 0437 21 001 Rev. A; 0437 21 101 Rev. A; 0437 21 201; 0437 21 202; 0437 21 301; Manufacturer's Window Specification (Sash); Manufacturer's Window Specification (Casement); Design and Access Statement (Revised) dated February 2024.

Reason: For the avoidance of doubt and in the interest of proper planning.

All new external work shall be carried out in materials that resemble, as closely as possible, in colour and texture those of the existing building, unless otherwise specified in the approved application.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policy D1 of the London Borough of Camden Local Plan 2017.

Informative(s):

1 Reasons for granting permission.

Planning permission was granted on 1st May 2019 (2018/5691/P) for the installation of double glazed slim-line timber windows. However, works appear not to have been implemented within the time scale.

The proposed replacement windows would match as closely as possible the existing windows in terms of materials, design, opening methods and proportions.

There would be some degree of increased thickness to the frames in order to accommodate the double-glazed panes; however, in this instance, the use of suitably designed slim-line units are considered to be an appropriate and sympathetic change which would preserve the character and appearance of the host building.

The windows would also improve the thermal performance of the building which is a material planning consideration.

There are no amenity concerns to neighbouring properties given the proposal would replace existing building features and fenestration.

The site's planning and appeals history has been taken into account when coming to this decision. No objections have been received following statutory consultation.

As such, the proposal is in general accordance with policies A1, CC1 and D1 of the Camden Local Plan 2017. The proposed development also accords with the London Plan 2021; and the provisions of the National Planning Policy Framework 2023.
